

Specific Delivery requirements for Ecolab / ESSERS Barcelona, ES.

1. Safety

All drivers will be required to comply with Ecolab safety policy and procedures. Site rules must be always obeyed.

The following standards are established and maintained at all warehousing facilities and apply strictly to all employees, contractors, and visitors.

At a minimum, the following Personal Protective Equipment must be worn:

- High visibility clothing
- Long sleeved shirts (desired)
- Full leg pants (desired)
- Safety shoes (desired)

All visitors must comply with the below safety requirements:

- NO alcohol
- NO smoking (including the use of electronic cigarettes)
- The floor of the truck must allow a 'safe access' for all elements for the loading / unloading operation.
- All drivers must report to reception their arrival
- Dock were to place the truck will be communicated to the driver as soon as the information will be known.
- Before the loading / unloading tasks trailer wheels will be chocked, the engine switched off and the brakes applied
- Pedestrians should use the pedestrian crossing
- If there has been a potential movement of the cargo during the trip that would conditionate the unload of the cargo, it should be communicated at the reception desk

- If there is a known leakage of part of the cargo, it should be communicated at the reception desk
- Access to the warehouse is forbidden
- Access to changing room, bathroom and toilet is granted
- Access to vending machines is granted

2. Cargo related topics:

Cargo placement:

- IBC's must be loaded with the faucet pointing towards the closest lateral side of the truck
- All pallets must be loaded with ADR pictograms and labels pointing towards the back of the
- References, quantities, and net weight must be visible on the packaging and matching with the ones on the paperwork. Gross weight must be informed on the paperwork as well.
- Cargo must be palletized.
